### Mission:

6. The week following the member's Main Event presentation, said member will host the Professional Development Discussion portion of the meeting.
7. Policies are subject to change.
8. Members agree to indemnify and hold harmless **n<sup>3</sup>** and its individual members for claims arising from participating in the networking group.
